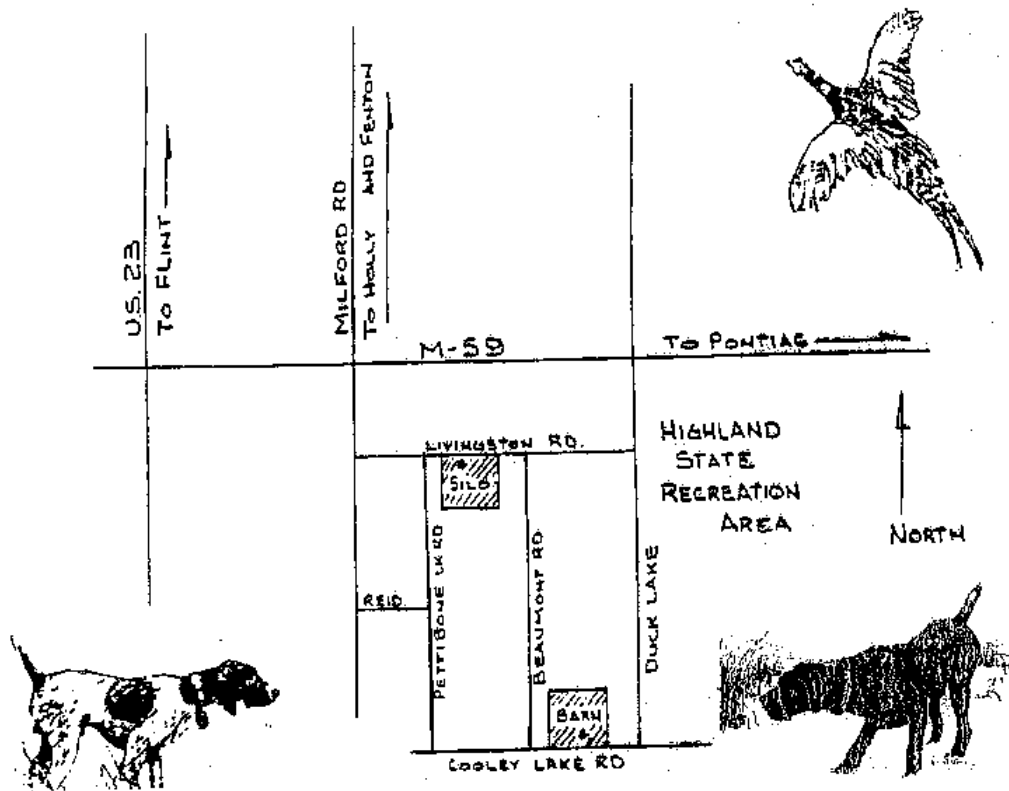
AGREEMENT
